Mrs. Martin,

As for the attack D [REDACTED] experienced, there were quite some important information missing here.

1. D [REDACTED] recalled clearly on that day, he reported to Mrs. Hernandez that the boy hit him on his back and also kicked him hard on his private part twice.
2. He reported the incident to multiple people on Tuesday and Wednesday, including his doctor and the police officer. He actually provided more details at the police station. There was no interaction between the boy and D [REDACTED]. The boy attacked him out of the blue.
3. We took him to see different doctors for the rest of that week. That was why D [REDACTED] did not go to school. He was referred for further checkups after the attack. We still are not done seeing doctors.
4. He was very stressed when he went to see different doctors. He was embarrassed to be checked on. He was very scared there was something wrong. After that

week, he did not want to talk about it anymore. He even changed his story a bit so that he does not need to be checked on again.

He also told Mrs. Newell that he was not comfortable to talk about it when she asked him about the incident on February 6th.

5. I am very concerned about what had happened to him. If there is no consequence, the attacked can occur again. Can you guarantee that D [REDACTED] is safe at school?

On the other hand, he was consistently punished, questioned and pressured because of the wrong perception people have on him. He spoke out his feelings about being treated differently and he got out of school suspension. He waved to his friends and received an in school suspension for making "punching motion". How can he feel he is fairly treated?
