


Hi there,

I wanted to wrap around as there were two pieces of this previous email that I wanted to complete.

First, when you reported that Lease made that statement, my team and I worked through our threat assessment protocol that we do with all students making a comment such as this. The inquiry led us to understand the context as well as the level of intent. Our assessment concluded that the words used were transient which means that there was no viable plan to act on the words, therefore, they did not pose a viable threat. Even in this case, we do follow-up with the student to provide the learning and contact parents about the words of concern. All of that has happened since we were notified of this interaction.

Hi Mrs. Martin,

Thank you for your reply.

It is very reasonable with how Dece's report was dealt with. It happened a while ago. He actually handled it himself and asked Lee whether he meant what he said. Dece didn't make a big deal and just shared it with us. We felt we should let you know as Lee clearly disliked or despised Dece for some reason. It also explains why Lee kept on telling on him.

In contrast, D had a totally different experiences last year in Wolf Springs. One classmate made up a random lie saying he had a murder list. D was restrained from going to his classroom. He was questioned 3 times: by Peggy Salts, by Meaghan Graber, by both of them with me being present. Pegponded strongly with the same answer: he didn't know anything about a murder list. He never threatened anyone at school. He was then later questioned by the attorney we found, he had the same response. On February 10th, during the re-entry meeting at the district, he was questioned again in front of everyone. He had the same answer: he didn't know anything about a murder list. Even though we were told there by the Chief Legal Counsel that there was NO murder list, we were still forced to transfer to Cedar Hills without any reasonable explanation. The worst part is school wide announcement was already made about a "murder list". It caused so much fear and panic in the community for something never existed. After the re-entry meeting, based on the school announcement, my child was identified as a "disruptive" kid, a sociopath, and faced "consequences" by leaving Wolf Springs.

I had to share this with you so that you could understand why he is so anxious, why he doesn't feel safe and secure at school. As a principal and educator yourself, I am sure you know the impact that anxiety has on children: they could not focus, learn, and socialize. In worse cases, they could not even go to school. It happened to D back in late March when the rumors about his expulsion went wild in his class and Cedar Hills.

I am grateful that you are making so much efforts to arrange the meeting with the Speech Pathologist.
